



## **Community Outreach** a service provided by Newcastleton & District Community Trust

### **CONFIDENTIALITY POLICY**

The Outreach Listening service is confidential. We will not discuss anything about you outside of the Community Outreach Team without your explicit agreement, except in exceptional circumstances. For example, we would have a duty to inform your GP if we were concerned that there was a serious risk of harm to yourself or others. Confidentiality is a most important part of this service, as part of our ongoing professional development we undergo regular training, during which we may talk about issues in general, and not specifically.

### **PERSONAL DATA**

The service stores data in accordance with the Data Protection Act. The team keep their own records of their work, and these notes are held securely and confidentially for six years, after which they are destroyed. These records do not form part of any other record system within the Trust. The service also stores basic information about each client on a secure and confidential database, which is also kept separate from any other record system. This information is used to compile aggregate data and monitor the service. No information that can be traced back to individuals will be released by the service.

### **PRIVACY STATEMENT**

When you engage with Newcastleton & District Community Trust as a service user, donor, or volunteer, we may need to add personal data to our database to help with ongoing business matters. In line with the Data Protection Act, we will ensure that the data we hold is relevant, accurate, adequate, and not excessive. We will not use it to contact you for purposes other than those intended, and we will not pass on your information to third parties.

Normally the only information we hold comes directly from you. Whenever we collect information from you, we will make it clear which information is required to provide you with the information, service, or goods you need. You do not have to provide us with any additional information unless you choose to.

We will store your information on secure servers where we restrict access to appropriate staff members. All our staff members are briefed on handling personal information securely and sensitively.

We would also like to contact you in future to tell you about the work we are involved in, and in some cases, ways in which you might like to support Newcastleton & District Community Trust. You have the right to ask us not to contact you in this way. We will always aim to provide a clear method for you to opt out. You can also contact us directly at any time to tell us not to send you any future marketing material.

You have the right to a copy of all the information we hold about you. To obtain a copy, please write to Newcastleton & District Community Trust office. After verifying your identity, we will provide the information free of charge within 14 days.

#### **ONLINE PRIVACY STATEMENT**

**Newcastleton & District Community Trust is committed to protecting your privacy when you visit our website.**

When you visit the site, you do not have to give us any personal information about yourself. If you choose to e-mail us or to complete an on-line form, Newcastleton & District Community Trust will not pass on this information to third parties. Any personal data collected through this website will be treated as confidential in line with the principles of the Data Protection Act 1998.

Like many websites, to track traffic flows our site uses 'cookies'. These are text files that identify users' computers to our server but do not identify individual users. When users enter our site, their computers will automatically be issued with cookies. We use Google Analytics to measure the use of the site, including the number of visitors and how frequently different pages are viewed. This will help us to develop and improve our site. The data we collect will not be used to identify any user personally.
